## **Refunds/Cancellations Policy**

The Society of Construction Law appreciates that at times it is necessary to cancel bookings to events and to request refunds. However, the SCL will have incurred a cost as a direct result of a booking being made.

If you cancel 6 months or over, we will deduct 10% of the full price before issuing a refund. If you cancel between 3 months and 6 months, we will deduct 25% of the full price before issuing a refund. If you cancel between 1 month and 3 months, we will deduct 50% of the full price before issuing a refund. If you cancel between 10 days and 1 month, we will deduct 80% of the full price before issuing a refund. If you cancel within 10 days of the event no refund will be issued.

However, if it is possible to sell the place/s then the SCL will make a full refund less an administrative fee of EUR 20 per place.
